

Motorsport UK Membership Terms and Conditions

1. Membership

- 1.1** When you apply for a Motorsport UK Licence ('Licence') you will become a Member of Motorsport UK and agree to abide by these terms and conditions. Membership will commence on the date of purchase and will automatically expire at the end of the calendar year.
- 1.2** Every Member who actively participates in motorsport and who takes out or renews a Licence with Motorsport UK regardless of type or grade, agrees to abide by its General Regulations, Safeguarding Policy and Guidelines, Code of Conduct and Anti-Doping Policies, copies available on request and are available at www.motorsportuk.org
- 1.3** Motorsport UK shall be entitled to refuse an application form or suspend or cancel the Membership of any Member at its absolute discretion.
- 1.4** Motorsport UK shall only communicate with the registered Member or their parents/guardians if the Member is aged 17 or under.
- 1.5** Motorsport UK reserves the right to amend and update Membership products at any time. Benefits will only be provided to Members aged 16 or over. Where a Member is younger than 16 or otherwise in a category of Members restricted by age, with the exception of personal accident cover, Motorsport UK reserves the right to provide the benefits to an appropriate parent or guardian of the Member.
- 1.6** When the purchase and/or renewal of a Motorsport UK Licence has been successfully processed, the membership services team at Motorsport UK will endeavour to package and deliver the Licence by post within 15 working days following receipt of cleared funds. For the avoidance of doubt, funds will be deemed cleared when the debit or credit card transaction has been processed successfully or in the case of cheques, within five working days when the cheque has been banked. An applicant with no health or other problems appertaining to their application may, on payment of an Express Handling Fee, apply for priority handling for Motorsport UK to issue their Licence within three working days or same working day (three-hour service).
- 1.7** Motorsport UK will not have any liability to a Member in respect of a failure to carry out or delay in carrying out any of Motorsport UK's obligations under these terms and conditions caused by any circumstances outside its reasonable control.
- 1.8** If a Member wishes to cancel their Motorsport UK Licence and Membership within 14 days of the purchase, they will receive a refund of any monies paid (after deduction of a £15 administration fee), providing the Licence has not been used for entry or participation in any

Motorsport UK registered events and/or have used to access any of the Membership benefits. Any refunds will be credited to the payment card used to make the purchase once the Licence Card issued has been returned to Motorsport UK.

- 1.9** No refunds, in full or part, will be given to any Member wishing to cancel their Motorsport UK Licence and Membership after fourteen (14) days.
- 1.10** Membership is personal to each Member, is not transferable and shall not be transferred or resold under any circumstances. Motorsport UK reserves the right to suspend the use of Membership and/or any associated benefits for a period of time; to withdraw its use and such benefits completely and/or to terminate Membership if the Member breaches any of these terms and conditions (or has reasonable grounds to suspect such a breach). Motorsport UK shall not be obliged, in these circumstances, to make any refund to a Member if their Membership and/or associated benefits are suspended or withdrawn or if their contract for the purchase of a Membership is terminated.
- 1.11** Motorsport UK collects personal information when an individual becomes a Member, or when Members use services or products that require the collection of personal information. Motorsport UK will use this information to provide the services requested, maintain records, notify Members of important information regarding an individual's Membership, develop the organisation and send the Member information on topics that may be of interest to them, where a Member has opted in to receive such information. Motorsport UK may occasionally pass such information to its suppliers or partners to enable Members to receive services or products relating to Membership which are not fulfilled directly by Motorsport UK. Members may opt-out of receiving similar communications directly from those suppliers or partners of Motorsport UK at any time by emailing privacy@motorsportuk.org. Motorsport UK does not otherwise share such information for marketing purposes with any other organisations. - 1.12** Motorsport UK will not have any liability to a Member for any late delivery or non-delivery of a Licence Card, documents or other materials resulting from the actions or omissions of any postal service provider.
- 1.13** Motorsport UK may, from time to time, update its Membership terms and conditions. Members are advised to refer to the Membership terms and conditions prior to the renewal of their Membership annually, with copies available on request.
- 1.14** The failure by Motorsport UK to exercise or any delay by Motorsport UK in exercising a right or remedy provided by these terms and conditions does not constitute a waiver of the right or remedy or a waiver of other rights or remedies. A waiver of a breach of any of these terms and conditions does not constitute a waiver of any other breach and shall not affect the other terms and conditions.

- 1.15** Motorsport UK or any of its suppliers or partners shall not be liable for any breach of its obligations hereunder resulting from causes beyond its reasonable control. Such events include, but without limitation, war, threat of war, riot, national calamity, civil strife and terrorist activity or threat of terrorist activity, industrial dispute, natural or nuclear disaster, adverse weather conditions, fire, unavoidable accident, breakdown of equipment, pandemics, malicious damage, act of God and all similar events outside our control.
- 1.16** These terms and conditions together with any associated application form/process comprise the entire agreement between Motorsport UK and a Member in relation to the purchase and use of their Membership.
- 1.17** If any of these terms and conditions are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, they shall, to that extent, be severed from the remaining terms and conditions which shall continue to be valid to the fullest extent permitted by applicable laws.
- 1.18** These terms and conditions shall be governed by and interpreted in accordance with the laws of England and Wales and subject to the exclusive jurisdiction of the Courts of England and Wales.
